THE STATE BJP on Wednesday took out a candlelight march in Kolkata over the death of a West Bengal worker in Kerala. While Kerala Police said it was suicide, the family of the deceased al-

leged it was murder. Hemanta Roy (25), a resident of Role village in Bankura, had gone to Kerala for work at the end of September. He was working as an electrician at Panavally in Alappuzha district. Roy is survived by wife and a six-month-
